Under Colorado law, state Political Committees can accept contributions of up to **\$625 per two-year election cycle from individual U.S. citizens, corporations, labor organizations, LLPs, LLCs, and sole proprietorships**. Contributions from Political Committees and Small Donor Committees are limited to \$625 per two-year election cycle from such entities that support or oppose the same candidates. Contributions from foreign nationals, foreign corporations, and foreign governments, are prohibited. Contributions are not tax-deductible.
